Boarding rates are calculated like a hotel. The day you check in you pay for that day, regardless of what time you check your pet in. Check out time is 10:00 AM, after 10:00am you are charged for day boarding unless your pet stays with us another night. We will do our very best to keep your pet in our hotel accommodations. If the room is booked by another guest, your pet may be placed in a smaller room until pick-up. **Please schedule your pets carefully!** We are a small facility and therefore will fill up quickly. You will be charged for the completed reservation in its entirety.

With anything over 2 weeks, boarding requires a non-refundable deposit that will be put toward your balance at the end of your pets stay. Cancellations must be made 48 hours in advance.

Four Paws cannot guarantee that your pets' belongings will be returned to you intact at the end of their stay. We will, of course, do our very best, but we urge you to not to bring **ANY** valuable or irreplaceable personal items.

All photos took of your pet while at the facility are property of Four Paws and may be used in promotional material, including but not limited to print, video, social media, and internet. No compensation will be given to the owner.

By signing this contract, the owner states that the pet is free of all contagious diseases and is to the owner's best knowledge, in good health. A fecal examination will be done once a year to ensure that your pet or any other pet does not contain/spread parasites. The owner also guarantees that their pet(s) are current on required vaccines. Canine kennel cough can be contracted anytime your dog encounters another dog. The vaccine does not immunize all dogs against all strains of kennel cough. Four Paws and its staff will in no way be held liable for any strain of kennel cough that your pet may contract while boarding.

Four paws encourage the socialization of our borders; however, there are inherent risks associated with dogs playing together. If during boarding, grooming, or doggie daycare, we feel that your pet requires immediate veterinary care, we will secure the necessary care. **If** medical treatment is necessary, Four Paws will contact you and you will be responsible for all charges incurred. Four Paws will **NOT** be liable for death, illness, or damage caused by illness/disease. Especially organ failure, jumping or scaling fences, unavoidable/unforeseen causes including bite wounds/injury. In the case of a deceased animal, Four Paws will attempt to contact the owner, and the animal will be placed in a freezer until the owner returns home.

By signing this contract, the owner certifies that their pet(s) have not harmed or demonstrated aggressive or threatening behavior towards any human/animal and agrees to notify Four Paws in the future if this changes. Four

Paws reserves the right to refuse or revoke admittance if the pet displays any behavior deemed dangerous or inappropriate and/or does not meet health requirements set forth.

There is a chance your pet may become soiled and /or wet/matted. Four Paws will make every attempt to keep your pet clean. It is the responsibility of the owner to schedule bathing/grooming services at an additional cost if wanted/needed.

This agreement binds the owner to be held responsible for any damage their pet causes at Four Paws.

All boarding charges are due when you pick up your pet(s). If pet(s) are not **collected within 10 days** after the due date, the said pet may be disposed of or taken to the animal shelter at Four Paws discretion. Notice of disposal/surrender will be given by certified mail to the owner's last known address, according to our records, at least **10 days prior** to such action being taken. No further notice will be given. The customer hereby acknowledges and agrees that any account that becomes delinquent is subject to a collection service. The customer agrees to pay all court costs and reasonable attorney fees for collection of all past due amounts owed, plus interest of 18% per annum on all such amounts outstanding.

I understand and do agree to the above terms and policies for the boarding of my pet and consideration for the services of Four Paws, agree to hold harmless, acquit, will indemnify and forever discharge the corporation from all manner of actions, suits, and judgments. The terms shall not be limited to veterinarian services in the event I am not available. **I authorize** Four Paws to act as my agent in case emergency services are needed and agree to pay all costs. **I have read this contract and agree to the terms. I understand it is legally binding for all pets staying at Four Paws, not in the future.**

Payment is expected at the time of service. By signing this document, you acknowledge your agreement to pay for the services rendered during your visit. You also acknowledge that if this account is referred to by an attorney or collection agency, you will be responsible for all attorney fees, court, and finance charges for 1.5% per month or 18% per annum.
