Four Paws & Hooves Veterinary Clinic Rules of the Suites

PLEASE READ THE FOLLOWING STATEMENTS AND SIGN BELOW

Boarding rates are calculated like a hotel. The day you check in you pay for that day, regardless of what time you check your pet in. Check out time is 12:00 p.m. After 12:00 p.m., you are charged for day boarding. Please schedule your pet's stay carefully. We are a small facility therefore, we will fill up quickly. You will be charged for the complete reservation in its entirety.

Pets are released during regular business hours. It is the owner's responsibility to inform the clinic if their pet pick-up will be delayed and they will assume all costs associated with an extended stay. All boarding charges are due when you pick up your pet(s). If pet(s) are not collected within 10 days after the pick-up date, Four Paws & Hooves Veterinary Clinic may assume the pet(s) have been abandoned and the said pet(s) may be disposed of (including euthanasia) or taken to the animal shelter at Four Paws & Hooves Veterinary Clinic's discretion. Notice of disposal/surrender will be given by certified mail to the owner's last known address, according to our records, at least 10 days prior to such action being taken. No further notice will be given. The customer hereby acknowledges and agrees that any account that becomes delinquent will be subject to a collections service. Customer agrees to pay all court costs and reasonable attorney fees for collection of all past due amounts owed plus interest of 18% per annum on all such amount outstanding.

Four Paws & Hooves Veterinary Clinic is open to the public Monday - Friday from 8 a.m. - 5 p.m. and Saturday - Sunday from 8 a.m. - 10 a.m. If after hours pickup or drop-off is required, an appointment must be made in advanced with our office staff. An additional fee of \$10.00 will be applied.

Four Paws & Hooves Veterinary Clinic requires a \$50.00 non-refundable deposit that will be put toward your balance at the end of your pet's stay. Cancellations must be made 72 hours in advance or the amount of your pet's stay will be charged to the credit card on file.

Four Paws & Hooves Veterinary Clinic cannot guarantee that your pet's belongings will be returned to you at all or intact at the end of your pet's stay. We will, of course, do our very best, but we urge you to not leave ANY valuable or irreplaceable personal items.

All photos taken of your pet while at the facility are property of Four Paws & Hooves Veterinary Clinic and may be used in promotional materials including, but not limited to, print, video, and social media. No compensation to the owner will be given.

By signing this contract, the owner states that the pet is free of all contagious diseases and is, to the owner's best knowledge, in good health. The owner also guarantees that their pet(s) are current on required vaccines. Canine kennel cough can be contracted anytime your dog comes in contact with another dog. The vaccine does not immunize all dogs against all strains of kennel cough. Four Paws & Hooves Veterinary Clinic and its staff will in no way be held liable for any strain of kennel cough that a dog may contract while boarding.

Four Paws & Hooves Veterinary Clinic encourages the socialization of our dog boarders. However, there are inherent risks associated with dogs playing together. If, during boarding, grooming or doggie daycare, we feel that your pet requires immediate veterinary care, we will secure the necessary veterinary care. In the event that medical treatment is necessary for your pet, Four Paws & Hooves Veterinary Clinic will contact you. The owner is responsible for all charges incurred. Four Paws & Hooves Veterinary Clinic will NOT be liable for death, illness, or damage caused by illness or disease, organ failure, jumping or scaling fences, unavoidable or unforeseen causes including bite wounds or injury. In the case of a deceased animal, Four Paws & Hooves Veterinary Clinic will attempt to contact the owner and the animal will be placed in a freezer until the owner returns home.

By signing this contract, the owner certifies that their pet(s) have not harmed or demonstrated aggressive or threatening behavior towards any human or animal and agree to notify Four Paws & Hooves Veterinary Clinic in the future if this changes.

Four Paws & Hooves Veterinary Clinic reserves the right to refuse or revoke admittance to any pet that displays any behavior deemed dangerous or inappropriate and/or does not meet the health requirements set forth.

There is a chance your pet may become soiled and/or wet and matted. Four Paws & Hooves Veterinary Clinic will make every attempt to keep the pet clean. It is the responsibility of the owner to schedule bathing/grooming services at an additional cost if wanted or needed.

This agreement binds the owner to be held responsible for any damage their pet(s) cause to Four Paws & Hooves Veterinary Clinic.

I understand and do agree to the above terms and policies for the boarding, grooming, and maintenance of my pet(s) and in consideration of the services of Four Paws & Hooves Veterinary Clinic, agree to hold harmless, acquit, will indemnify and forever discharge the corporation from all, and in all manner of action and actions, suits, damages, judgments, executions, claims, and demands whatsoever, in law or in equity from damage, loss or claims arising from any known or unknown pre-existing conditions of my pet(s). The terms, special services, or handling shall include but are not limited to veterinarian services in the event I am not available. I authorize Four Paws & Hooves Veterinary clinic to act as my agent in the event emergency veterinarian services, or care-taking necessary and I agree to pay all costs. Or claim shall include, but not limited to death, injury, or shock. Said pre-existing conditions shall include, but not limited to illness, previous injury, skin or coat conditions, medical conditions, advanced age or nervousness.

You must have documents from your vet of vaccinations, Bordatella (kennel cough), Rabies, and Distemper (Dhlpp) current within 1 year (we will accept a 3 year rabies and distemper) and a negative fecal test within 6 months.

All animals entering the clinic for boarding must be current on vaccinations and free of parasites (fleas and ticks). If not, they will be treated upon entering, at the owner's expense.
